2. If the buyer does not fulfil the agreement to purchase the said motorcycle, the deposit will not be refunded.
3. If the buyer is unable to get the loan approval for the motorcycle, the deposit is not refundable.
4. It is agreed that the seller is to hand over the spare keys and other documents which are related to the said motorcycle, to the buyer, upon time of delivery.
5. At the time of hand over, the seller undertakes to preserve the condition of the motorcycle as at the time of sale and with all accessories intact
6. All fees & levies imposed by the Land Transport Authority (LTA) directly associated with this Vehicle's ownership transfer are to be borne by the Buyer.
7. The Buyer is to purchase at his own expense, a motor insurance policy for this Vehicle which is valid as of the date of ownership transfer and for not less than the full period of valid road tax
8. The Buyer and the Seller acknowledge that each of them has read and understood the terms of this Agreement, and has sought his / her / its own independent legal advice on the terms herein, and executed this Agreement based upon such party's own judgment and independent legal advice (if sought).
9. This Agreement constitutes the entire agreement of the parties relating to the subject matter addressed in this Agreement. This Agreement supersedes all prior communications, contracts, or agreements between the parties with respect to the subject matter addressed in this Agreement, whether oral or written.
10. This Agreement shall be governed by the laws of the Republic of Singapore.
